

Measurement models



Global identification: Identification With All Humanity Scale – “People all over the world” (C-IWAH)




Unused items: IWAH 5

Justice beliefs (“normal” times, local): Basic Social Justice Orientation Scale (J-BSJO)



Justice beliefs (“normal” times, global): Measure of justice beliefs about global inequality (J-JBGI)




Justice beliefs (“normal” times, global): Measure of behavioural intentions toward global inequality (J-BIGI)


Justice beliefs (pandemics, global): Global Resource Distribution Principles Scale (GRDP)



Model 1: Justice beliefs (pandemics, global) ~ Global identification (IWAH)




